## Why our work must continue

Every day we see the benefits of YHA's programmes and activities on physical and mental health. And we see first-hand the impact of residential breaks on young people's abilities to develop their social skills, self-confidence, resilience and relationships.

### Residentials for young carers

### Bird hide for YHA Eskdale

YHA Eskdale is a small 46-bed hostel situated at the foot of Hardknott Pass, in the quieter western side of the Lake District. It is a picturesque and beautiful place to walk, hike and enjoy the landscape of the surrounding hills and wilderness.

The hostel is environmentally friendly, using renewable energy in the form of biomass and solar panels. It is also set in 15 acres of private grounds great for exploring the natural environment. A mapped nature trail complete with a boarded walkway introduces guests to the local flora and fauna. and in June 2014 work started on a field study hide after a generous gift left in memory of David Hardisty by his sisters Marian and Jovce. He loved the hostel and the wildlife in the area. When the hide was opened in April 2015 it was named the David Hardisty Hide. Many guests continue to gain enjoyment from this bequest.



Marian also remembered YHA Eskdale in her will. In 2017, her gift supported the improvement of the reception area, as well as the planting of bulbs and spring shrubs to enhance the grounds.



A big plus to the hostel is the superbly designed bird hide in the hostel grounds where you can see a large variety of birds coming to the feeders at close range - we counted eight different species on our visit.

## Tax effective giving

## Charitable gifts can increase significantly when tax effective giving rules are applied.

Charitable gifts can affect Inheritance Tax on larger value estates and additional tax breaks are available in some circumstances to people leaving a legacy to charity.

### What's the tax effect of giving?

You'll want to understand how taxes could affect a legacy gift. Tax could have a significant effect on the value of your estate especially if your net assets amount to more than the Nil Rate Band.

You are unlikely to be liable for Inheritance Tax on a legacy if your estate passes to a spouse or a civil partner and both are domiciled in the UK.

Married partners, including civil partners, have individual allowances. One partner can benefit through the unused allowance of their deceased spouse. So if one partner dies and £30,000 of their allowance is unused, their surviving spouse will inherit the remainder of the allowance.

Tax is a complicated topic and you will want to make sure that the legacy you leave to an organisation you support is as financially efficient as it can be.

## Leaving a gift in your will

We understand that, when you consider a will, your loved ones come first. So, your priority will be making sure that they are provided for.

However, many people also choose to leave a charity gift to an organisation that shares their values – or has delivered life-changing experiences and life-long memories.

### Have your say on your estate

We should all make a will regardless of how much money we have or property we own. It's the only way of ensuring our wishes are carried out.

Your will can be as simple or detailed as you choose. It can outline your preferred type of funeral and make sure your estate – including any legacy gift you choose to leave – is dealt with according to your exact wishes.

YHA advises you choose your executor(s) and seek professional help through a qualified and experienced solicitor or use our free will service.

### Why a will is important

If you die without evidence of a will you're intestate. It means your estate and possessions will be subject to the rules of intestacy and that can lead to complex, lengthy and emotional legal and financial discussions at an already difficult time for your family.

If you have no immediate family and don't leave a will, the Government may receive your assets.

### Changing your will

You should review and refresh your will to reflect any changes in your life - or the lives of those mentioned in it.

You may not need to completely re-write it. A codicil is a simple legal addition that can update some changes.

Keep your will in a safe place, let your executors know where it is and keep a second copy with your will writer or solicitor.

### **Choosing your gift**

There are different types of legacy gifts. These include:

### Pecuniary legacy

A specific amount of money.

### Residuary legacy

A gift or a share of your estate after costs and pecuniary gifts are made.

### Specific legacy/bequest

The gift of a particular item such as shares, chattels or your entire estate.

Writing a will ensures your estate - including any charity gift you choose to leave - is dealt with according to your exact wishes.

The size and type of your gift will usually depend on your personal circumstances.

A residuary legacy is an excellent way of avoiding having to quote specific sums of money or individual items. So, you won't need to keep updating your will if your financial or family situation changes. For example, you may decide to leave 50% of your estate to an individual organisation. The actual value of the gift may rise and fall due to changes in your circumstances and inflation. However, the percentage you chose will be calculated on any amount left.

## The right words

### What should I say in my will?

These are the kind of words you could use if you choose to leave a gift to YHA in your will.

### Residuary legacy

I give all (or a % share) of the residue of my estate to YHA (England & Wales), Trevelyan House, Dimple Road, Matlock, Derbyshire DE4 3YH. Registered Charity Number 306122, for its general charity purposes.

I direct that the receipt of the treasurer or duly authorised officer shall be a valid and appropriate form of discharge.

### **Pecuniary legacy**

I give the sum of (amount in words and figures), free of tax to YHA (England & Wales)... [continue as above].

### Specific legacy/bequest

If you wish your gift to be used in a specific area or for a particular project just insert, 'and express the wish it be used for...' YHA will make every attempt to comply with your request.

### The legal words

## Some terms that might be used when writing your will

#### **Assets**

Items of value owned by the deceased, including holdings of bank accounts and shares, property, furniture etc.

### **Beneficiary**

Someone who will benefit from your will.

### **Bequest**

A gift in will (other than land or buildings).

### Chargeable estate

An estate or portion of an estate whose value is above the threshold for Inheritance Tax.

### **Charging clause**

A clause in a will that permits a solicitor or other professional to charge for work in a personal capacity, or undertaken, which did not require the services of a professional. If no such clause is included, the Trustee Act 2000 implies its inclusion.

#### **Chattels**

Moveable tangible articles of property.

#### Codicil

A simple document incorporating changes to a will, either by adding, deleting or altering the provisions made in the will.

### Deed of variation/family arrangement

A variation to a will of intestacy after death – usually as a tax planning device.

#### **Estate**

All ownership and monies, vested or contingent both in possession and reversion that are capable of being disposed by the will.

### Executor(s)

The person(s) you choose to be responsible for administering your will.

#### **IHT (Inheritance Tax)**

Tax levied on the value of an estate, which exceeds a threshold. The amount is sometimes altered each year following the Budget. It may increase in some circumstances if your spouse has died before you - seek advice about this.

#### Intestate

The term used when someone dies without leaving a will.

#### **Probate**

Authorisation confirming that the will is valid and your executors can carry out your wishes.
